**NARRATIVE:** On July 05, 2016 at approximately 1455 hours Detectives from the Chico Police Department conducted a probation search at 2291 Mulberry Street. Two residents were contacted inside the home and identified as Eric Rehse and Elizabeth Stevens. Rehse and Stevens are adults and both reside in the home. Both were determined to be on searchable probation.

During the search, a significant amount of stolen property was located both inside the home and on their property. Several recent burglary victims were identified as a result of locating the stolen property. They are as follows:
