PREFERENTIAL PARKING RESIDENTS

Your current permit(s) <u>may</u> expire June 30, 2022

Permit sales begin June 10th, 2022

ENFORCEMENT WILL BEGIN JULY 8, 2022

Online Permit Renewals Available

<u>RESIDENTS</u> and <u>TENNANTS</u> in the above areas may now apply online for Preferential Parking Permits for the preferential parking area in which they reside. You may now submit applications for Preferential Permits at <u>Chico.getapermit.net</u>. A maximum of five (5) parking permits may be issued for each address. Resident permits are digitally linked to your vehicle's license plate numbers and window stickers will no longer be necessary for these permits. For all regulations regarding Preferential Parking Permits please refer to the Chico Municipal Code 10.30.130.

RESIDENTIAL PARKING PERMITS

<u>RESIDENTS</u> in the above areas may apply for preferential parking permits for the preferential parking area in which they reside for a maximum of three years. Preferential parking permits for residents are \$24.00 for each permitted year (e.g., a three-year permit expiring in June 2025 will cost \$72.00). **Maximum duration available for purchase is** *three* **years.**

To obtain a preferential parking permit, residents must provide:

- Proof of residency is required for ALL applications- new and renewal; <u>AND</u>
- If a tenant, a copy of the current lease which shows the name of the tenant and the term of the lease. Tenants may purchase preferential parking permits up to the end of their lease agreement.

These can now be uploaded directly onto the website for your convenience.

GUEST PARKING PERMITS

Guest permits are available for temporary visitor parking in your preferential parking area. Guest permits are \$17.50 for each permitted year (e.g., a three-year permit expiring in June 2025 will cost

\$52.50). **Maximum duration available for purchase is** *three* **years.** Guest permits may only be used in the same block as the address of the owner's residence. Guest passes may only be used by those visiting as a guest of the residence or by someone providing services to the residence.

To obtain a guest pass, the property owner or designated agent must:

Provide a copy your photo ID <u>AND</u> provide proof of residency by submitting a copy of <u>one</u> of the following items:

- Most recent utility bill.
- Most recent rent receipt.
- Current lease agreement.

Guest permits are only available for purchase at the Finance Office located at 411 Main Street.

If you are an owner and you do not want to allow your tenant to obtain guest permits, you must notify our office immediately.

Applications received by mail **MUST** contain proof of residency. Applications without this information will be returned by mail. Checks received for incorrect amounts will also be returned by mail.
