

EXHIBIT B

SCOPE OF PROFESSIONAL SERVICES – BASIC; COMPLETION SCHEDULE

Amendment No. 1 Services in Bold:

TASK 1 - DEVELOPMENT OF STREET LIGHTING DETAILS

Provider shall use VISUAL software to prepare photometric analysis for various roadway classifications based on the preferred light fixture provided by the City. It shall be assumed that up to four types of street light poles and fixtures shall be included in photometric analysis:

1. Standard roadway light for typical roadways,
2. (a) Pendant style decorative street lights which shall be used in specific areas,
2. (b) Lantern style decorative street lights which shall be used in specific areas,
3. Trail/pedestrian scale light.

Based on the results of photometric analysis, Provider shall recommend light spacing for various roadway classifications.

Provider shall also meet with City staff to identify preferred brand and model of lighting poles and fixtures and develop a Qualified Product List (QPL) for streetlights. Based on the preferred lighting poles and fixtures selected by the City, Provider shall prepare up to six sheets of lighting details which shall be included in the City's Standard Plans.

TASK 2 – FOUNDATION DESIGN AND CHECK DESIGN

Mark Thomas shall provide foundation design for the City's three new light pole types (standard, decorative, and trail/pedestrian). Foundation size and reinforcement shall be determined. Anchorage details shall be coordinated with Provider. An independent design check by Mark Thomas shall be provided. Calculations shall be provided if required. CADD drafting shall be completed by Provider and shall be checked by Mark Thomas.

DELIVERABLES:

- Qualified Product List for streetlights
- Standard Details for lighting and foundations
 - Six (6) sheets for lighting
 - Three (3) sheets for foundations
- Design and Check Design calculations (if required) and foundation details

ASSUMPTIONS

- Up to four (4) types of street light poles and fixtures shall be included with three (3) different foundations

Completion Schedule

The Provider shall complete all services outlined herein ~~within six weeks of Notice To Proceed~~ **by September 20, 2024.**
