
**THIS SERVICE PROVIDER AGREEMENT AMENDMENT** (Amendment) is entered into on SEPTEMBER 6, 2022, between the City of Chico, a municipal corporation under the laws of the State of California (City), and GHD, Inc., (Provider). On January 22, 2020, City and Provider entered into "City of Chico - Service Provider Agreement" (Agreement). The provisions of the Agreement are hereby amended as follows:

1. The term of the Service Provider Agreement from January 22, 2020, to January 21, 2023, shall be extended for a period of one-year, terminating on January 21, 2024. Thereafter, the term of this agreement may be extended, at the option of the City, for a successive one-year period.
2. Exhibit C page C1-R2 is hereby superseded and replaced by revised Page C1-R3 attached hereto.
3. All other provisions of the Agreement shall remain in full force and effect.


