Amendment No. 1 in Bold.

Scope of Services - Basic

Vendor shall provide services as follows:

Eaton & Cohasset:

- Install approximately 600LF of 3-barbed wire fencing.
- Two (2) 7/8 used well pipe braces with caps.
- T-posts every 10LF.
- Two (2) ten-foot gates to make one 20ft opening.
- One pedestrian walk-through set at 32-inches.
- **Install approximately 550LF of 4ft sheep and goat net fencing along the creek with one (1) top barb wire.**
 - **2 7/8 used well pipe braces with caps**
 - **T-post every 10LF**

Bruce & Humboldt:

- Install approximately 1,600LF of 3-barbed wire fencing.
- Two (2) 7/8 used well pipe braces with caps.
- T-posts every 10LF.
- Two (2) ten-foot gates to make one 20ft opening.

Services to be Provided by City

Provide access to City lots between the hours of 6:30 a.m. and 3:00 p.m., Monday through Friday, excluding Holidays.




