Reporting on income targeting requirements does not need to be included until December 31, 2019 for the period from January 1, 2014 through the end of the fiscal year covered by the report (June 30, 2019 for most housing successors), and every five years thereafter. However, it may be useful for housing successors to track this information on an annual basis to ensure the requirement is met every five years. <i>The required income targeting expenditures are that, over a five year period, the funds remaining after expenditures for monitoring and administration and rapid rehousing services, if any, must be expended for the development of housing affordable to and occupied by households earning 80% or less of the AMI, with at least 30% of the funds expended on the development of housing affordable to and occupied by households earning 30% or less of the AMI and not more than 20% of the funds expended on the development of housing affordable to and occupied by households earning between 60% and 80% of the AMI.</i>	Insufficient funds were available in the Housing Asset Fund until the year ending June 30, 2016. These funds have been held to allocate to a new construction multi-family project. An allocation will occur in the 2019-20 fiscal year to assist 75 units <30% AMI at the Creekside Place project. Thirty-three percent of available funds will be allocated to units with Households earning ≤30% AMI. All allocated funds will be to assist Households earning ≤50% AMI.

The housing successor is required to spend the excess surplus amount or transfer that amount to another jurisdiction as provided in Health and Safety Code Section 34176.1@(2) within three fiscal years.
