Description of Project: The 2023 Pavement Improvements project work includes slurry seal treatment on East Avenue from Cohasset Road to Manzanita Avenue and on East Lassen Avenue from Esplanade to Floral Avenue. Grind and overlay work will be completed on El Paso Way from East Lassen Avenue to approximately 125 feet north of El Varano Way. Additional work includes striping and pavement marking. No right of way will be acquired.
