SIDE LETTER AGREEMENT BETWEEN CITY OF CHICO AND SERVICE EMPLOYEES INTERNATIONAL UNION (SEIU), LOCAL 1021 REGARDING EXHIBIT "A" – SCHEDULE OF HOURLY PAY RATES

WHEREAS, pursuant to the provisions of the Meyers-Milias-Brown Act ("MMBA") and Article 1, Section 1.6, entitled "Letter Agreement for Variation of Provisions" of the Memorandum of Understanding between the City of Chico ("City") and Service Employees International Union (SEIU), Local 1021, effective January 1, 2022 through December 31, 2024 ("2022 MOU SEIU-TC UNIT"), this Side Letter Agreement is entered into on July 16, 2023, between the City and the SEIU ("Letter Agreement") as an amendment to the 2022 MOU SEIU-TC UNIT.

WHEREAS, the City and SEIU have agreed to amend Exhibit "A" of the 2022 MOU SEIU-TC UNIT Schedule of Job Titles and Hourly Pay Rates (Appendix B-1); and have agreed to include the following position and pay structure in Exhibit "A" effective July 5, 2023 with approval of City Council:
