4.1 <u>Architectural Review 20-16 (Sayegh Brothers) – APN 002-610-050</u>: A proposal to construct a single story commercial building totaling 4,245 square feet on the west side of Bruce Road, 300 feet south of East 8<sup>th</sup> Street/California Park Drive. The new building would contain two commercial suites and the undeveloped site would be improved with 17 parking spaces and associated landscaping. The site is zoned CN (Neighborhood Commercial) and is a designated Neighborhood Commercial Use by the General Plan. The project is categorically exempt from review under the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15332 (Infill Development Projects).
