## 4.0 PUBLIC HEARING AGENDA

Architectural Review 19-15 (Sloop Medical Building) – Northwest Corner of Jan Court and Forest Avenue -- APN 002-210-066 et al. A proposal to construct a new medical office building and install associated site improvements including parking and landscaping. The site is designated Office Mixed Use on the City's General Plan Land Use Diagram and zoned OC (Office Commercial). The site consists of approximately 2.09 acres over seven parcels. The project is categorically exempt from review under the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15332 (Infill Development Projects). The proposed project was continued by the ARHPB at its meeting on August 5, 2020.
