- 4.1 Architectural Review 21-03 (B20 Mixed Use Project) 1993 Bruce Road, APN 018-390
  021. A proposal to construct a new vertical mixed use project consisting of 60 affordable, senior housing units and approximately 10,000 square feet of commercial space in a three-story structure. The 2.5-acre project site is located on the northeast corner of Bruce Road and E. 20th Street.
