# 4.0 PUBLIC HEARING AGENDA

4.1 Architectural Review 21-22 (Oleander Community Housing) – 2324 Esplanade (APN 006-100-049): A proposal to construct a new, gated and entry-controlled, 38-unit residential development, and associated site improvements including outdoor amenities, parking, and landscaping on an approximately 1.3-acre lot on the east side of Esplanade. The three-story apartment building would be located on the northern portion of the lot, fronting on Esplanade between Rio Lindo Avenue and Mission Ranch Boulevard. The project would include 37 units of permanent supportive housing for individuals experiencing homelessness and mentally disabled individuals. One additional unit would be reserved for an on-site resident manager. The project would also include on-site case management offices where individualized supportive services would be provided to the residents. The building would also include a community center and elevator. The site is designated Commercial Mixed Use (CMU) on the City of Chico General Plan Land Use Diagram and zoned Community Commercial (CC).
