4.0 PUBLIC HEARING AGENDA

4.1 Architectural Review 21-10 (Self Storage) – 2260 Park Avenue (APN 036-430-194): A proposal to expand an existing mini storage facility to include an additional five storage buildings. The five proposed buildings would be approximately 31,518 square feet total in size. The site is currently designated Manufacturing and Warehousing on the City of Chico General Land Use Diagram and zoned ML (Light Manufacturing/Industrial). The project has been determined to be exempt from further environmental review pursuant to California Environmental Quality Act Guidelines Section 15332 (In-Fill Development). ABSTAIN: None. 4.2 Architectural Review 21-25 (Chico Bar Triangle) – Southeast corner of Bar Triangle Street and Robailey Drive, APN 002-190-025-000. A proposal to construct five multifamily residential apartment buildings containing a total of 70 affordable housing units. The new buildings would be three-story structures with tuck-under parking provided on the ground floor and additional uncovered parking available onsite. The project would include associated circulation and landscaping improvements as part of the development of this 2.97 acre site. The project site is designated Medium High Density Residential on the City of Chico General Plan Land Use Diagram and zoned R3 (Medium High Density Residential). The project has been determined to be categorically exempt from further environmental review pursuant to CEQA Section 15332 (Infill Development Projects).
