### 5.1. CONSIDERATION OF A PERMIT FOR BUTTE COUNTY PRAYS WORSHIP/PRAYER EVENT IN CITY PLAZA (50 HOURS)

Derrick Sanderson, from Butte County Prays (Applicant), requests a permit to hold a 50-hour, multiple day worship/prayer event at City Plaza from October 17, 2019 to October 19, 2019. This event is part of a larger event called Awaken the Dawn/Tent America scheduled to be held in 1,000 cities across the nation.

### 5.2. CONSIDERATION OF A NEW AGREEMENT WITH THE CHICO AREA RECREATION & PARK DISTRICT (CARD) TO LEASE THE CHICO CREEK NATURE CENTER.

In October 2018, the Chico Creek Nature Center (CCNC) non-profit provided notice of its intent to dissolve. The City has worked with the Chico Area Recreation District (CARD) to transfer operations of the Center to CARD through a new lease agreement. The BPPC will also consider discharging the CCNC from any further loan obligations for constructing the City's facility (*Report - Chris Constantin, Assistant City Manager*).

- Discharge Loan Obligation- Discharge the Chico Creek Nature Center of any further loan obligation upon execution of a new Ground and Property Lease with CARD and formal termination of rights with the CCNC; and
- Authorize Write Off- Authorize the City to write off the loan balance receivable of\$169,800.

### REPORT IN BRIEF:

Derrick Sanderson, from Butte County Prays (Applicant), requested a permit (Exhibit A) to hold a 50-hour, multiple day worship/prayer event at City Plaza from October 17, 2019 to October 19, 2019. This event is part of a larger event called Awaken the Dawn/Tent America scheduled to be held in 1,000 cities across the nation. Information regarding this event is attached as Exhibit B. The Applicant requested the use of the Plaza all day on Saturday, however there is another event scheduled from 7am to 1 pm on that day. As an alternative, the Applicant requested the use of the area at the top of the stairs of the Chico Council Chamber Building from 6 am to 2 pm while the other event is held, and to resume their event in the Plaza from 2:00 p.m. to 6:00 p.m. The City Manager has approved the use of this alternate location during this time.

- Applicant shall conduct a final inspection of the venue and remove any associated trash after the entire event.



### **SECTION 3 - CONDITIONS FOR PARK USE**

### You Are Responsible for Knowing the Park Rules. Please Observe the Following:

Alcohol Alcohol is not permitted in any City Park or Playground.

Portable BBQ's may only be used next to existing BBQ's in Lower Bidwell Park and Five Mile Recreation Areas. BBQ's

Must observe all California vehicular codes including one-way streets. Riders are expected to be courteous and yield to **Bicycles** equestrian and pedestrian traffic. Helmets must be worn at all times in Upper Park, except when on pavement. Riders must stay on designated trails. Bicycle riding is not allowed in Caper Acres or on the Sycamore pool deck.

Bounce houses and other similar play equipment are only permitted with a reservation and upon approval by the Park Division. The operators of this equipment must provide proof of insurance. Bounce houses are not allowed in Caper

Acres

Campfires No campfires allowed.

**Bounce Houses** 

Camping No overnight camping allowed. Bidwell Park is a "day use park" only.

Permittee is required to completely clean up area at the conclusion of event. Additional garbage bags may be obtained from the General Services Department at time of reservation. (12R.04.180 CMC) Clean up

**Damages** Any damage to City property as a result of this event will be repaired at permittee's expense.

Dogs may be off leash from 5:30 AM until 8:30 AM in Lower Park -- All other times dogs must be on a leash. Along Dogs

the north side of Upper Park Road, dogs may be "off leash" anytime. While "off leash," dogs must remain under control via master's voice. Dogs are not allowed in Caper Acres, One-Mile or Five-Mile swimming areas, or

designated swimming holes in Upper Park.

Electrical All power extension cords, sound amplification equipment, and staging to be supplied by permittee. Permittee shall

provide "tripping" prevention devices over power cords crossing any pathway.

Glass No glass containers allowed in any City Park or Playground.

Horses Horses must stay on designated trails. Horses are not allowed in One-Mile or Five-Mile Recreation Areas. Horses

must cross the creek at approved crossings. Safe and courteous riding is the Park standard.

Noise No loud or unusual noises are allowed, including: radios and headsets that can be heard over 50' away.

Music/Amplified Sound at One-Mile Recreation Area, please, face all speakers away from Woodland Ave.

Park Closures Lower Park is closed from 12:00 am (midnight) until 5:00 am every day, unless directly and actively proceeding to a destination outside of the park. Upper Park is closed at 9:00pm, October – March and 11:00pm, April - September

unless posted otherwise.

Signs/Defacing Defacing of trees, benches, tables, any park fixtures, open ground, or paved roads/paths with markings, staples, tacks, or signs is prohibited. No pinatas, or accessories shall be affixed to trees. Only barricades, cones, or self standing devices

may be used for these purposes.

**Smoking** Smoking is not permitted in any City Park or Playground.

Swimming While in the 1-Mile swim area compliance with lifeguards is required for public safety. Pool is open and lifeguards are

on duty from Memorial Day through Labor Day.

Vegetation No taking, cutting or injury of any vegetation in the Park is allowed.

While gates are closed, limited use of vehicles to set up for event is permitted. Vehicles must be in compliance with Vehicle Traffic the one-way designation of the roadway, must yield to all other activities (walking, jogging, bicycling, and

horseback riding), must travel with flashers on and may not exceed ten (10) miles per hour. Permittee shall provide adequate signs and supervision to avoid conflicts between vehicles, bicycles, equestrians,

and general public. Only emergency vehicles will be allowed access through the area of South Park Drive which has been closed to

motor vehicles.

No vehicles are permitted to travel or park on grass areas.







Review, Consideration, and Recommendation of New Lease Agreement with the Chico Area

**Recreation District** 

### **REPORT IN BRIEF:**

In October 2018, the Chico Creek Nature Center (CCNC) non-profit provided notice of its intent to dissolve. Since October, the City has worked with the Chico Area Recreation District (CARD) to transfer operations to CARD through a new lease agreement. The City and CARD will be executing a new lease agreement, and the CCNC non-profit will be terminating their lease at the same time. City staff also are recommending discharging the CCNC from any further loan obligations for constructing the City's facility and to write off the outstanding loan balance from the City's account receivables.

**Recommendation:** The City Manager requests the Bidwell Parks and Playground Commission consider recommending the following actions to the City Council:

- 1) **Execute New Lease** Execute a Ground and Property Lease By and Between The City of Chico and the Chico Area Recreation District (CARD);
- 2) Accept Old Lease Termination Accept Chico Creek Nature Center's lease termination request effective on the date of execution of a Ground and Property Lease with CARD;
- 3) **Discharge Loan Obligation** Discharge the Chico Creek Nature Center of any further loan obligation upon execution of a new Ground and Property Lease with CARD and formal termination of rights with the CCNC; and
- 4) **Authorize Write Off** Authorize the City to write off the loan balance receivable of \$169,800.

### **FISCAL IMPACT:**

The new lease agreement would result in quarterly payments of \$500 for a total revenue to the City of \$2,000. CARD would take responsibility for all internal and external capital needs of the leased property except for the City providing road base material at no cost for the adjoining parking lot. The actions related to the loan would eliminate a General Fund receivable of \$169,800.

### **BACKGROUND:**

The Chico Creek Nature Center (CCNC) leases property, including two City owned buildings, in Bidwell Park along East Eighth Street between Cedar Grove Picnic Area and the Deer Pen. As consideration for such use, and in lieu of the payment of rent, the CCNC operates a nature museum and conducts educational classes and programs on nature and the environment for the benefit of the public. The original lease was executed July 1, 1996, amended on July 21, 2005, and terminates December 31, 2027.

One of the City owned buildings, the administration building, was destroyed by an arson fire in April 1998. By City Council motion on November 10, 2005, the City Council approved a request from the CCNC for a loan in the amount of \$185,000, bearing an interest rate of 5.24 percent per annum, to cover the balance of increased construction costs for the new exhibit and classroom facilities (Project) within the new building that were not covered by grant funds, insurance proceeds, or existing donations. It was the intention of the CCNC to conduct fundraising activities to generate funds to make the loan payments and, in the event fundraising activities failed to generate sufficient funds, the CCNC had agreed to use interest generated from its Paradise Community Foundation endowment (endowment subsequently moved to the North Valley Community Foundation) as security for the loan to make the loan payments. Upon completion of construction, the first loan payment was made July 15, 2008. It should be noted that the City retains ownership of any improvement, including the facilities built by the loan, grant and fundraising.

After making four quarterly payments, the CCNC requested a deferral of loan payments for three years due to unanticipated costs associated with the completion of the new facility which required the CCNC to shift operating funds to capital expenses and to use the interest generated from its endowment for operating expenses, making the endowment funds that had been identified as security for the loan unavailable. The City's Finance Committee recommended deferral of the loan payments that were due July 15, 2009 through April 15, 2010, with associated penalties, and the deferral of the loan payments due July 15, 2010 through April 15, 2011, without penalty, but recommended that deferral of the third year of payments be considered following staff analysis of a business plan to be submitted by the CCNC. Subsequently Council authorized the City Manager to execute Amendment No. 1 to the agreement subject to these conditions.

The Finance Committee recommended the third year of deferred loan payments (July 15, 2011 through April 15, 2012), without penalty, based on staff review of the CCNC's business plan which showed they were making progress toward financial stability and could potentially be in a position to resume quarterly loan payments in fiscal year 2012-13. Council approved the recommendation at which time Council suggested staff review the loan's interest rate relative to the City's actual rate of return on investment and that Council consider a future discussion regarding forgiveness of the loan. Council authorized the City Manager to execute Amendment No. 2 to the agreement subject to these conditions.

In 2012 the Finance Committee considered the CCNC's request for an additional three years of deferred loan payments (July 15, 2012 through April 15, 2015). In addition, as requested by Council, staff reviewed the City's actual rate of return on investment and recommended that the interest rate be adjusted from 5.24 percent per annum to 1.80 percent per annum to more accurately reflect the City's actual rate of return on investment. The Finance Committee recommended to Council that only a two-year deferral be granted, through April 15, 2014, and that the interest rate be adjusted to 1.80 percent per annum retroactive to the payment due July 15, 2009. Council authorized the City Manager to execute Amendment No. 3 to the agreement subject to these conditions.

By letter dated April 2, 2014, the CCNC requested an additional two-year deferral of loan payments, from July 15, 2014 through April 15, 2016. When the Finance Committee considered this request, the Finance Committee was split on the potential action with one option being forgiving the loan and the other being not to forgive the loan. The request was forwarded to the City Council without a Committee recommendation.

### Loan Payment Difficulties Persist

At its May 20, 2014 meeting, Council authorized staff to prepare Amendment No. 4 to the agreement that would: (1) reset the accumulated interest and penalties owed for the period beginning July 15, 2009 through April 15, 2014, to zero (\$0) so that only the current principal balance of \$181,026.95 was owed; (2) adjust the interest rate from 1.80 percent per annum to 3.42 percent per annum from July 15, 2014 forward; and (3) establish interest only payments for one year beginning with the payment due July 15, 2014. Staff prepared Amendment No. 4; however, the CCNC did not agree with these terms and did not sign the amendment.

In March 2015, to minimize the impact on the City on a potential future liability, the City Council approved the use of one-time, General Fund, carry over funds from 2013-14 to move the debt obligation from Fund 347 - Zone I Neighborhood Parks Fund to the General Fund. This still resulted in an accounts receivable; however, if the City ever forgave the loan, the City would not have to identify funds to cover the loan obligation in the neighborhood parks fund.

### New Lease and Loan Arrangement Resolve Loan Default

The City began meeting with the CCNC to attempt to resolve the loan default by negotiating a new lease and loan agreement. The City met through the summer and fall to finalize a draft agreement for the City Council and Bidwell Park and Playground Commissions' consideration. Further, the City also drafted an amendment to the loan agreement to align with the new lease agreement.

On December 15, 2015, the City Council approved a new lease agreement and loan amendment with the Chico Creek Nature Center. The new lease agreement established an increasing lease payment that would be applied to the loan. The loan agreement amendment #4 revised the principal loan amount to be \$181,026.95, thereby eliminating any interest accruals to date, and set the interest rate to zero (0) percent until June 30, 2020. After June 30, 2020, the interest rate would return to the original loan rate of 5.24 percent. The lease and loan changes were intended to lessen the burden for the Chico Creek Nature Center to make progress towards payment of the loan.

After execution of the new lease and loan amendment, the Chico Creek Nature Center executed an Operating Agreement with the Chico Area Recreation District to assume responsibilities over the facility and its operations. The City has been receiving steady quarterly lease payments and applying the payments to the loan principal. As of today, the Chico Creek Nature Center is compliant with all loan and lease requirements.

### CCNC Desires to Dissolve

In a letter dated October 24, 2018, the Board of Directors of the Chico Creek Nature Center informed the City of their intention to dissolve the non-profit corporation. City staff have been working with the Chico Creek Nature Center and CARD to transition operations and lease interest formally over to CARD. The actions requested in this report would authorize the City Manager to execute a new lease agreement with CARD for the Nature Center. Additionally, staff recommend discharge and write off the loan and debt payments from the Chico Creek Nature Center organization. In a letter dated July 8, 2019, the Chico Creek Nature Center specified a requested acceptance for termination on or after August 6, 2019.

### **DISCUSSION:**

The City, CARD and Chico Creek Nature Center (CCNC) agree that there is interest in preserving the services offered at the Nature Center location, as it provides broad benefits to the community and is an information center for Bidwell Park. It is also intended that the City and CARD will partner to expand cultural and programmatic opportunities at the Nature Center location by continuing to seek grants to create a Maidu village which should draw more use of that area of the park as well as to increase services being provided. CARD desires to continue operating the Chico Creek Nature Center, while the formal CCNC non-profit would dissolve. From the public's perspective, no change is anticipated in the transition from the CCNC organization to CARD.

Other alternatives are limited given restrictions on the property

In evaluating the leased property and any alternate use, the value of the land must be a consideration. According to a local commercial real estate broker, the value of any property is based on its commercial and revenue generation ability.

As a property restricted by being part of Bidwell Park, there are limited commercial options for the property. Viable options may include other non-profit or service entities, as well as private service providers. It was estimated at the time of the 2015 lease agreement negotiations that the property's rental capacity may be about \$1,000 to \$1,500 per month.

Currently, the CCNC is a presence in a city building that would otherwise not have an immediate tenant. This has resulted in the CCNC covering utility expenses as well as conducting basic maintenance of the facilities. Additionally, the City received a Proposition 40 state grant of \$200,000 to assist in the construction costs of the facilities which came with a 20-year restriction. The restriction requires the City to continue to operate a public type museum until May 2024. With this added restriction, the property's rental capacity is further reduced. In all, there are no other viable options at this time. CARD's continued operations are believed by City staff to be in the best interest of the public.

### CARD become Lessee and Operator

CARD has a history of successful operations of City facilities including being the lessee and operator of several City parks. The positive relationship between the CARD and the City results in the City providing City property to CARD and CARD adding value by providing services and maintaining the City's facility. It is a win-win for Chico residents. Under the proposed lease agreement, CARD would move from operator to lessee who will operate the City facility. CARD would continue to operate the facility in compliance with Proposition 40 for the term of the grant and will fully maintain the internal and exterior of the City facilities.

The North Valley Community Foundation which holds the permanent endowment whose interest was provided to the Chico Creek Nature Center, will cease its annual payments to the CCNC organization upon its dissolution and will have to determine another entity to award the interest payments that is closest to the original wishes of the endowment's contributor. It is anticipated that CARD would be the entity closest to such wishes, and as such, the North Valley Community Foundation may continue its annual interest distribution to CARD as it continues to operate the CCNC.

CARD agrees to continue making a quarterly payment to the City which would ensure any costs associated with overseeing and assisting in the City facility would be covered. Additionally, CARD and the City will continue to partner in both this and other facilities to maximize the services provided to Chico residents.

The following exhibit highlights the key provisions of the lease agreement:

This item will be before the Bidwell Park and Playground Commission on July 29, 2019 and heard at the City Council on August 6, 2019.

### Discharge of Outstanding Loan Balance

The City and Chico Creek Nature Center non-profit entered into the latest loan agreement on May 11, 2006 to provide gap financing for the difference between grant funds and private donations to rebuild the nature center facility.

For a variety of reasons over time, the CCNC has had difficulty being able to make payments and required multiple years of deferrals. Only since the new Lease Agreement did the CCNC make continuous progress towards reducing the loan balance. The quarterly payments paid through the lease agreement were to be applied to the loan balance, but the amounts paid, would still require many more years than originally contemplated in the original loan agreement. Now, with notification of the CCNC's desire to terminate the non-profit's operations, the loan does not appear to be viable.

The Loan Agreement acknowledges that the City's land and buildings benefit from this loan. According to Section V of the Loan Agreement, "Inasmuch as the Project and the land upon which the Project will be constructed are owned by the City, this Loan is granted without security." Since construction, the CCNC has provided continuous service and benefit to the Chico community through the City's facilities. The transfer of responsibility from CCNC to CARD will continue this benefit. However, with the termination of the CCNC non-profit, the outstanding issue of the loan obligation must be addressed.

In evaluating the CCNC arrangement starting in 2013-14, City staff believe the use of a loan to a non-profit for the building of a City facility and the continued obligation for the non-profit to pay for a loan which benefit's the City is not a consistent practice with other City leases. In most cases, the City leases space, building or land for no, low or subsidized rates to non-profits which provide some type of beneficial service to the Chico public that the City would have to provide, or for which would not occur otherwise. Originally, it appears that the loan was intended to ensure the proper construction of the City's facility and to ensure there was a stop gap should grant and fundraising efforts not achieve the targeted resources necessary to complete the project. If the City desired to provide such nature services, it would

have been better to have the City fund the part of construction which would complete the project since the building was ultimately fully owned by the City and the services provided by the CCNC were for the benefit of the general Chico public.

The dissolution of the CCNC non-profit would render the outstanding loan as uncollectable as it's both unsecured and the applicable agency would no longer exist. As the endowment is permanently restricted and in the custody of the North Valley Community Foundation, it is not an asset of the CCNC to be considered in any action related to the loan.

City staff believe that the best approach is to thank the CCNC for the many years of wonderful service to the Chico community, allow CARD to step in to continue operations, and to discharge the loan and write off any existing balance owed to the General Fund.

### **CONCLUSION:**

City staff believe the transfer of responsibility from the CCNC to CARD is a positive approach and consistent with a desire to partner with CARD on providing robust public recreation services. City staff also believe discharging the loan is in the public interest whose debt has been best served by the more than 12 years of service by the Chico Creek Nature Center non-profit since the loan was executed. The City Manager recommends approval for a lease agreement with CARD, accepting the termination of the existing CCNC lease, discharging the CCNC non-profit from any further obligations, and writing off the remaining loan balance from City receivables.

# **Increasing Resources**

### Sales Tax

- General can fund any expense eligible for General Fund resources. Requires majority public vote to implement.
- Special must provide the types of expenditures to be funded and funds are restricted for that purpose. Requires 2/3 public vote to implement.
- $\frac{1}{4}$  cent = \$4.5 million,  $\frac{1}{2}$  cent = \$9 million
- $\frac{3}{4}$  cent =  $\frac{13.5}{13.5}$  million,  $\frac{1}{1}$  cent =  $\frac{18}{18}$  million
- $1 \frac{1}{4}$  cent = \$22.5 million,  $1 \frac{1}{2}$  cent = \$27 million

## General Obligation Bond

- Restricted for capital related expenditures. Requires 2/3 public vote to implement.
- With an estimated 27,719 identified parcels, a per property tax of about \$36 would be necessary to generate \$1 million.



# **Increasing Resources**

### Parcel Tax

- Restricted for a specific purpose(s). Requires 2/3 public vote to implement.
- With an estimated 27,719 identified parcels, a per property tax of about \$36 would be necessary to generate \$1 million

## Utility Users Tax

- Unrestricted. Requires a majority public vote to implement.
- A 1% increase would generate about \$1.3 million.

### Franchise Fees

- Unrestricted. Further, garbage franchises are locked for a period of 12 years and may not be an option to increase without garbage hauler concurrence.
- A 1% increase would generate about \$700,000.

## **Key Findings**



- A majority of voters are now pessimistic about the direction of the Chico area.
- Homelessness, public safety and housing are among the community's top priorities.
- Initial support for a parcel tax for local parks and recreation is near the twothirds threshold needed to pass. Support for a bond measure is lower.
- Reducing crime and homelessness in parks, providing clean, safe parks and recreational programs, and upgrading park safety features would be important components of a parcel tax measure.



A majority are now pessimistic about the way things are going in the Chico area.




Q4. Do you feel that things in the Chico area are going in the right direction or do you feel things are off on the wrong track?







# Parcel Tax & Bond Measure Segmentation




While only about half indicate they would support both measures, three quarters of respondents are supportive of at least one of the two measures, a parcel tax OR a bond measure.






## **Conclusions & Recommendations**



- A parcel tax measure may be feasible for the March 2020 ballot but a bond measure would be a significant challenge.
- Given the survey findings and the current community climate following the Camp Fire, we recommend that CARD begin an extensive public outreach and engagement effort before placing a measure on the ballot. Informational communications are essential to the community's understanding of the need for revenue, particularly funds to maintain park programs and safety.
- A parcel tax measure would be vulnerable to opposition. Therefore, a successful measure would likely require a well-coordinated, privately funded outreach effort to ensure that voters understand how additional funding would reduce crime and homelessness in parks, provide clean, safe parks and recreation for local residents, and help maintain the Chico area as a desirable place to live, work and raise a family.

#### **NARRATIVE**

#### 1. Updates

- a. <u>Caper Acres</u>– The Parks Division will also be hosting a National Night Out event from 5:30PM-7:30PM on Tuesday August 6<sup>th</sup> to celebrate the opening of the new crooked house. Guest speakers will preview what's happening next with the Caper Acre renovation plans. The Chico Target retail store will be hosting games. The Chico Police Officers' Association will be grilling hotdogs. There will also be appearances by a Chico Police K-9 Unit, Chico Police VIPS and Chico Fire and Rescue.
- b. <u>Alliance for Workforce Development</u>— The grant funding for the work crews has been exhausted. The work crew and the Parks Division and the work crew under the Butte Environmental Council at Teichert Ponds have both been dismissed. The crews accomplished an amazing amount of storm damage cleanup and vegetation management during their service.

#### 2. Maintenance Program

Staff continues daily cleaning and safety inspections of all recreation areas including: grounds, playgrounds, picnic sites, roads and paths, coupled with daily cleaning and re-supplying of all open park restrooms. Maintenance and repair of park fixtures, posting reservations, illegal camp clean up and the constant removal of graffiti from all park infrastructure.

- a.Lower Park: Staff worked on down tree clean up, lawn and irrigation issues and pool maintenance.
- b. Middle Park: Standard maintenance with minor vandalism repairs.
- c. Upper Park Staff cleared downed trees from Yahi trail and Guardian trail
- d. Upcoming projects: Grade and repair parking lots throughout the park, Repair Guardian trail bed under the peregrine cliffs, install par course equipment in lower park.

#### 3. Ranger and Lifeguard Programs

- a. <u>Lifeguards</u>– July has been a busy month for Lifeguards. The have rendered aid to for cuts and scrapes and rescued two actively drowning individuals.
- b. <u>Rangers –</u> There has been a significant increase in illegal encampment activity in Bidwell Park and greenways. Multiple service requests are received every day,

#### 4. Volunteer and Donor Program

- a. <u>Annual Upward Bound Volunteer Day</u>– Over 200 Upward Bound students combined with PALS volunteers and the Friends of Bidwell Park contributed 450 hours of vegetation management service to South 1 Mile on June 14<sup>th</sup>.
- b. <u>Target Volunteer Day</u> 24 employees from Target retail stores in Chico, Yuba City and Redding contributed 72 hours of volunteer vegetation management time to Lower Park and donated \$600.00 in Target gift cards to the PALS volunteer program!

SUBJECT: Street Trees Division Report

#### **NARRATIVE**

#### 1. Updates

a. Service calls regarding Summer branch drop continue to increase. Of 141 calls for service received in June, 77 were for cracked, hanging or downed limbs. This is up from 61 calls received in May.

#### 2. Planning/Monitoring

a. <u>Damage Reports</u> – UFM completed one damage report for Risk Management. The claim related to fallen limbs and vehicle damage.

#### 3. Planning and Building Development

- a. UFM reviewed one plan review. Comments included CMC19.68 tree preservation measures during construction to protect veteran oak trees.
- b. UFM assisted in signing off on several final City inspections. The Veterans Clinic off Bruce road and other smaller developments required that additional work is completed to correctly stake the landscape trees.

#### 4. Miscellaneous

- a. Irrigation installation for native trees planted along Woodland Avenue has been completed. Three additional Valley oak trees were also planted by Alliance For Workforce Development. In total, 54 new Valley oaks and ten Redbuds are on irrigation.
  - In the Fall, Parks and Tree Divisions will look at planting additional native shrubs to help screen the parking areas off South Park Drive.
- b. Public Works Engineering located acorns collected from the Cohasset Road project about 8 years ago. In the Fall, Tree Division will check for viability and attempt to germinate some of them. Any viable seeds can be used to grow native tree stock.

#### 5. Maintenance

a. Work is ongoing to maintain emergency access in the open space behind residential properties on Picholine Rd. A large Live oak was cleared up by Tree Crew that was blocking emergency access. Code Enforcement also assisted with removal of improved structures that would potentially block emergency access.

#### 6. Outreach, Training and Education

- a. The Tree Division continued training employees in the Senior Maintenance and Maintenance Worker classifications. Practical training is ongoing to acquire ISA Tree worker certification. The employee in the Maintenance Worker classification has also commenced practical training to acquire a Commercial Driver License (CDL).
- b. UFM attended training to test possible new tree inventory software.
- c. UFM attended webinars on trees and Stormwater management.as well as Remediating Compacted Soils Compromised by Urban Construction
