5.2.1 CONSIDERATION OF NOTICE OF PREPARATION OF AN EIR FOR THE DRAFT VEGETATIVE FUELS MANAGEMENT PLAN

An Environmental Impact Report (EIR) is being prepared for the draft Vegetative Fuels Management Plan ("VFMP") prepared for City-owned parks, greenways and open spaces. Pursuant to CEQA Guidelines § 15082(a), the Commission reviewed the Notice of Preparation requesting comments on the scope and content of the EIR and heard public comments.

Commissioner Smith-Peters requested that the Verbena Fields project be dropped from the list of implementation projects in the VFMP, and that a project to address the understory of Lower Bidwell Park and Comanche Creek be added to the list of projects.

Woody Elliott addressed the Commission. Email Comments were also received from Raphael Genova.

The Commission directed Staff to consult with the Mechoopda Indian Tribe on whether Verbena Fields should be removed from the plan and report back to the Commission.

PROJECT

REPORT IN BRIEF:

The Bidwell Park & Playground Commission (BPPC) will receive an update and presentation from the City's consultants on the status of the Upper Bidwell Park Road Sediment Reduction Project and the environmental review for the project

Recommendation: None, this is an informational item only.

BACKGROUND:

The unpaved section of the Upper Park Road (UPR) in Bidwell Park between the Diversion Dam gate and the end of the road has been closed to private vehicles since 2012 when the road was severely damaged from winter storms. The City retained Pacific Watershed Associates (PWA) to assess and make recommendations regarding repairing and improving approximately 4.4 miles of the road between Horseshoe Lake and the end, which identified 43 erosion sites within this section of UPR that needed either road drainage repairs or redesign, and/or sediment control treatments. This project extends along 3.4 miles of Upper Park Road and will reduce and largely eliminate a total threat of 3,570 cubic yards of sediment from entering Big Chico Creek. The plan to make the necessary repairs and to the UPR has been approved by both the BPPC and the City Council

The City with the help from the Butte County Resource Conservation District was also successful in obtaining a Nonpoint Source (NPS) Grant administered by the State Water Resources Control Board (SWRCB) in the amount of \$706,352, with a local match of \$291,450 in existing Park Division Capital and Operating budgets (Fund 002) to complete the project.

DISCUSSION:

Staff and the City's consultants, PWA and BCRCD have been working on final project designs, environmental review, and the regulatory permits for the project. Biological and cultural surveys have been completed. Since this is an existing highly used historically graded and filled road, biological, botanical and cultural impacts from this project are considered low. Additional surveys and measures such as avoidance where possible, contractor education, and guidance by biologists and archeologists will also be implemented prior and during construction.

However, there will be the need to remove some trees, shrubs, and other vegetation when replacing the targeted culverts and realigning some of the road edges. The site with the most vegetation removal is Site 1, which is approximately 750 feet from the Horseshoe Lake Lot E gate but is also the site with much erosion and sediment. Site 1 and other sites, where needed, will be restored to natural stream flow, and by replanting native trees, and installing best management practices, such as reseeding and straw, on hydrologically connected disturbed areas.

ENVIROMENTAL REVIEW AND PERMITS:

Based on the CEQA surveys, PWA's experience in similar projects in other areas, and after consultation with the SWRCB, a CEQA Categorical Exemption is proposed for this project as follows:

- 1. **PRC Section 15301 Existing Facilities**, Restoration or rehabilitation of deteriorated or damaged structures, facilities, or mechanical equipment to meet current standards of public health and safety.
- 2. **PRC Section 15302. -Replacement or Reconstruction -** Replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced.

3. **PRC Section 15333 d)(6) - Small Habitat Restoration Projects** - project consisting of 5 acres or less with the primary purpose of improving habitat and reducing sedimentation. The culvert replacements will also be conducted in accordance with published guidelines of the Department of Fish and Wildlife and NOAA Fisheries.

Although the project is considered exempt from CEQA, permits will need to be obtained from the several regulatory agencies. Staff and the consultants are in the process of preparing applications for the following:


- 1. CA Department of Fish & Wildlife Lake or Streambed Alteration Agreement (LSAA or 1600 Permit)
- 2. State Water Resources Control Boards-Discharge of Dredged or Fill Material to Waters (CWA 401) Permit.
- 3. U.S. Army Corps of Engineers- Discharge of Dredged or Fill Material to Waters (CWA 404) Permit.

Staff will be filing the Notice of Exemption with the County Clerk and the State Clearing House, and the applications for the regulatory permits in the next week or so. In the meantime, work will continue on the preparation of the construction bid documents with construction on the project anticipated to begin in June 2021.

NARRATIVE

1. Updates

- a. <u>Illegal Encampments</u>— On 10/20/20, the City Council considered a 3-year plan to improve Chico's quality of life which includes authorizing up to \$1.8 million in supplemental appropriations for the following:
 - Action 1.2.C Sanctioned camping site at the Airport for 90 days (\$700,000)
 - Action 1.3.A Expand existing emergency shelter beds by 50 (\$300,000)
 - Action 1.3.B Short-term 160 bed emergency shelter beds (\$282,933 in CDBG funds)
 - Action 1.3.C Evaluate and conduct environmental assessment for a non-congregate shelter at the current BMX site (up to \$100,000).
 - Action 2.1.A Conduct fire risk assessment (\$100,000)
 - Action 2.2.A Municipal code enforcement (\$60,000)
 - Action 2.2.B Parks & waterways clean up (\$300,000)
 - Action 2.2.C Increase TARGET Team hours (TBD)
 - Action 2.2.D Invite partner organizations to participate in an outreach/engagement effort with TARGET Team (\$20,000)

The Council's approved all of the proposed Actions, except Action 1.2.C.—Sanctioned camping site. Staff is to come back with a possible alternative camping site location.

- b. <u>Council Action on Park Rules</u>—Also at its 11/03/20 meeting, the City Council will consider an ordinance that amends the Chico Municipal Code to add a new Chapter 12.18 to Title 12 to include the Park Rules currently found in Title 12R. This action, if approved by Council, will allow Rangers and the Police Department the ability to issue either infraction or misdemeanor citations to violators of Park Rules depending on the severity or frequency of the violations.
- c. <u>Commission Recruitments</u> Currently there is one vacancy on the Commission and four current Commissioner terms will expire in December 2020. The City Clerk will begin the Boards and Commissions recruitment process on November 1, with anticipated Council appointments to be made in January 2021.

2. Administrative and Visitor Services

a. <u>Park Reservations & COVID -19</u>— With the continued State and County restrictions on large gatherings, the Park Division is not allowing reservations for both public and private events in City park facilities.

3. Maintenance Program

<u>General</u> - Staff provides on a need and time basis the cleaning and safety inspections of all recreation areas including grounds, playgrounds, picnic sites, roads and paths, coupled with the weekend cleaning and re-supplying of all open park restrooms. Maintenance and repair of park fixtures, daily opening of gates, posting reservations, unauthorized camp clean up and the constant removal of graffiti from all park infrastructure.

a. <u>Lower Park</u>: Routine maintenance, Route 99 overpass foot bridge repair staff replaced more of the deck planks and noted that the complete structure needs replacement. Staff have reopened Caper Acres per the covid guidelines. Sycamore pool damage has been mostly been repaired from the fall tree at the south steps.

- b. <u>Middle Park</u>: Routine maintenance, (I. E. lawns, irrigation, building maintenance, ETC). The pump house at lot D is in the process of being rebuilt due to age and cars backing into it on occasion.
- c. <u>Upper Park</u>: Horseshoe Lake Lot E is an ongoing repair issue with the fence being ran into on a regular basis we need to find a better solution than replacing the materials, as they have doubled in price from last year. I have suggested changing the flow of the lot by making it a one-way loop. Not sure where that stands at the moment. I am open to suggestions so we can stop the daily destruction of the fence line. Staff delivered 80 cubic yards of chip materials throughout the Disc golf course. The new Bear hole sign was installed at the entrance to the parking area (see picture in this report).
- d. <u>Green way Parks</u>: Routine maintenance. As time and staff permit. Staff worked with Rangers and ACS to clean camps along Lindo channel this month.

4. Natural Resource Management

a. <u>Vegetative Fuels Management Plan</u>— The public comment period on the Notice of Intent to prepare a programmatic Environmental Impact Report (EIR) for the Vegetative Fuels Management Plan (VFMP) closed on 10/9/20. The Project Team is compiling the comments received and preparing the Draft EIR and the final Draft VFMP which are anticipated to be reviewed by the BPPC in December 2020.

5. Volunteer and Donor Program

- a. <u>BEC Bidwell Park and Creeks Cleanup</u> The 33rd annual Bidwell Park and Creek cleanup garnered over 550 volunteers that removed an estimated 20+ tons of debris from Chico's parks and creeks. The final numbers are still be tallied. Actuals will be released within a couple weeks. A huge thank you to the Butte Environmental Council for organizing such a successful event!
- b. <u>New Upper Park Signs</u>— The Explore Butte County Tourism District liked the new Bear Hole sign design (see Figure 2 in Photographs section) and have generously offered to provide funding in the amount of approximately \$5,000 to replace signs at other swimming holes and points of interest in Upper Bidwell Park.

NARRATIVE

1. Updates

- a. Tree Division has started tree pruning of the DCBA.
- b. West Coast Arborists continues working on the City removal list of dead dying and diseased trees.
- c. Public Works continues planning fall tree planting campaign with non-profit partners

2. Planning/Monitoring

 Damage Reports – There were two damage reports in September. Claims were for property damage to property from falling limbs

3. Planning and Building Development

a. UFM reviewed many plan reviews in the new Trakit permitting system. Comments included Tree Protection Zone enforcement, submission of adequate tree protection plans, correct tree planting methods.

4. Miscellaneous

a. CalFire State Coordinator for the grant funded Urban Forest Revitalization Project visited Chico for the annual inspection. The coordinator praised the ongoing efforts to re-canopy low-income and Disadvantaged areas of town that have denuded levels of tree cover.

5. Maintenance

- a. City tree crews commenced tree maintenance operations in the Downtown Core Business Area (DCBA). Trees are being trimmed to improve sidewalk, road and building clearance as well as to correct structural defects. See Figures 1 and 2. This pro-active program will improve the downtown environment
- b. City contractor West Coast Arborists (WCA) continued work on removal of dead and dying trees in various parts of the City. Locations that will make suitable replant locations and that have irrigation will be stump ground and added to the fall replant list.

6. Outreach, Training and Education

- a. UFM attended Tree Risk assessment Qualification (TRAQ) re-certification training, a webinar on Best Practices for the Development Plan Review Process, trees and water, soil assessments as well as qualified pesticide applicator CE education.
- b. UFM took part in a Connect Chico media outreach story. Topics included the upcoming fall leaf program, City reforesting efforts and upcoming maintenance programs.
- c. Butte Environmental Council released media outreach to promote the upcoming fall neighborhood community canopy campaign.




