1. CALL TO ORDER

Chair Stemen called the meeting to order at 6:35 pm. STF members and City staff were present as noted.

2. <u>APPROVE DECEMBER 15, 2015 MEETING MINUTES</u>

The 12/15/15 minutes were approved (4-0-3; Chastain, Donnan, Johnson absent).

3. DEVELOP STF WORK PLAN FOR CALENDAR YEAR 2016

Chair Stemen recapped the efforts of the STF to date to develop the 2016 Work Plan, and shared that this meeting is focused on completing the work plan. Principal Planner Vieg provided an overview of the work plan items identified in the draft memo to Council. The draft memo was included in the agenda packet and served as a starting place for the STF's continued discussion of its 2016 Work Plan priorities.

STF member Loker suggested that the University be included as a sustainability partner and invited to future STF meetings, as appropriate.

STF member Loker also inquired about the STF's discussion at its December 10, 2015 meeting regarding a gas tax, specifically regarding the legal aspects of its implementation. The STF again

acknowledged the significant political effort of implementing a gas tax, and directed staff to inquire with the City attorney regarding the proposal's feasibility.

STF member Loker inquired who would be updating the City's GHG Indicator.

Chair Stemen asked that non-residential energy efficiency upgrades also be included as continued focus for the STF in 2016.

The STF directed that Butte County staff be invited to the next STF meeting to discuss efforts to implement the County's Climate Action Plan.
