## 1. CALL TO ORDER

Chair Stemen called the meeting to order at 5:30pm. STF members, City staff, and guests were present as noted.

## 2. APPROVE DECEMBER 14, 2017 MEETING MINUTES

*The 12/14/17 STF Meeting Minutes were approved 3-0.* 

## 3. <u>DEVELOP STF WORK PLAN/SCHEDULE FOR CALENDAR YEAR 2018</u>

Deputy Director Vieg reviewed a draft memo to Council that highlights the STF's 2017 achievements, and identifies possible 2018 Work Plan items and a meeting schedule. The draft memo was used by the STF to finalize its 2018 Work Plan priorities and programs, and to set its meeting schedule.

In addition to what was already included in the draft Work Plan, the following topics were

discussed and recommendations were made by the STF regarding the Work Plan:

- The STF should conduct a comprehensive review of the CAP, identify any deficiencies, determine if additional measures are needed to meet the City's GHG emissions reduction goal, and provide recommendations to Council on additional actions that should be pursued.
- Continue investigating opportunities to work with North Valley Energy Watch on advancing energy efficiency efforts for City facilities and the community.
- Coordinate with the Energize Colleges Butte College Program (at no cost to the City) to continue last year's Million Watt Challenge education efforts via Chico Sustainability Facebook and the Sustainability website
- Discuss Vulnerability Assessment and draft adaptation strategies at the April 12<sup>th</sup> meeting.
- Invite Sherry Morgado from Butte County Public Health to a future meeting to discuss cooling centers and other health-related issues related to global warming.
- Invite waste haulers back to review quarterly reports required by Waste Franchise Agreement

The STF directed that the draft memo be updated to reflect direction provided at the meeting and shared with the Planning Commission and City Council.

## 4. <u>2017/18 CIVICSPARK INITIATIVE: UPDATE</u>

CivicSpark Fellow Marcussen provided the STF with an update regarding the effort to develop long-term strategies for mitigating anticipated local impacts of climate change. Marcussen is coordinating with CSU, Chico, and City and Butte County staff, in the development of a Draft Climate Change Vulnerability Assessment that identifies risks climate change poses to the community, and will also prepare draft adaptation and resiliency goals, policies, and objectives.

Marcussen shared that the data has been collected, and she is researching what other jurisdictions are identifying as strategies to address adaptation and resiliency.

#### 5. <u>REPORTS & COMMUNICATIONS</u>

Deputy Director Vieg shared that there is a draft Butte Plug-In Electric Vehicle (PEV) Readiness Plan being by a Technical Advisory Committee, and that a draft public review Plan will be available for review this Spring.

Urban Forester Bamlet shared a grant funding opportunity to pursue a street tree inventory and a long-term urban forestry management plan. Bamlet requested STF support and assistance with outreach.
