#### 3. CONSENT AGENDA

Commissioner Evans moved to approve the minutes from April 4, 2017. Commissioner Tuchinsky seconded the motion, which passed 6-0-1 (Arregui absent).

#### 4. PUBLIC HEARING ITEMS

4.1 <u>Modification of Mountain Vista Subdivision and Planned Development Permit (S/PDP 01-12), located at the northeast corner of Eaton Road at Floral Avenue; APN 016-200-131 (portion)</u>

Senior Planner Mike Sawley provided the staff report and answered questions

from the Commission. Mr. Sawley addressed concerns raised regarding the absence of conditioned bike paths adjacent to the area proposed for modification.

Chris Giampaoli, the applicant, addressed the Commission and answered questions regarding the changes.

Leo Martinez, neighbor asked for clarification regarding what will be built on the adjacent property.
