4.1 Amendments to Exempt Governmental Signs in Chapter 19.74 of Title 19 of the Municipal Sign Code: The proposed Sign Code amendments would exempt certain governmental signs that are installed in the City right-of-way or on City property. The proposed amendments also establish a new definition of Informational Sign Kiosk and facilitate the installation of these signs in the Downtown area. The proposed amendments to Title 19 of the Chico Municipal Code have been determined to be exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) (General Rule Exemption), and pursuant to Section 15311(a) (Accessory Structures – On Premises Signs) of the CEQA Guidelines.
