The site is located on the north side of Native Oak Drive, east of Bruce Road and south of Deer Creek Highway (Highway 32). The site is identified as Medium Density Residential on the General Plan Land Use Diagram and is zoned R2-SD2 (Medium Density Residential with Humboldt Road-Foothill Overlay). Pursuant to section 15162 of the California Environmental Quality Act, no subsequent environmental review is necessary, as there have been no substantial changes to the project which would require revision of the existing Oak Valley, Environmental Impact Report.
