4.1 Vesting Tentative Subdivision Map 21-01 (Reed Subdivision) 3051 & 3055 Burnap Avenue, APNs 007-150-030 and 007-150-032: — A request to subdivide 1.24 acres into 5 lots for single-family residential development. The proposed subdivision is located on the western side of Burnap Avenue, south of Eaton Road and north of East Lassen Avenue. The project is designated both Low Density Residential on the City of Chico General Plan Land Use Diagram and is located in the R1-AOB2 (Low Density Residential with Airport Overflight Compatibility Zone B2) zoning district. This project is categorically exempt from further environmental review pursuant to Section 15332 of the California Environmental Quality Act (Infill Development Projects).
