4. PUBLIC HEARINGS

4.1 Tentative Parcel Map 22-01 (Habitat for Humanity Wisconsin Street Parcel Map); Wisconsin Street, APN 005-391-014: A proposal to subdivide an approximately 1.3-acre site into four parcels for residential development. The site is located on the north side of Wisconsin Street, between Boucher and Everett Streets. The site is currently designated Low Density Residential (LDR) on the General Plan Land Use Diagram and is zoned R1-SD6 (Low Density Residential with Special Design Considerations Area No. 6 overlay). The project proposes a gross residential density of 3.08 dwelling units per acre, with the average net lot size being 10,189 square feet. The project falls within the scope of the Mitigated Negative Declaration (MND) prepared for the Wisconsin Street Acquisition. Pursuant to Section 15162 of the California Environmental Quality Act (CEQA) Guidelines, no subsequent environmental review is necessary. **Questions regarding this project may be directed to Associate Planner Tina Wilson at (530) 879-6807 or tina.wilson@chicoca.gov.**
