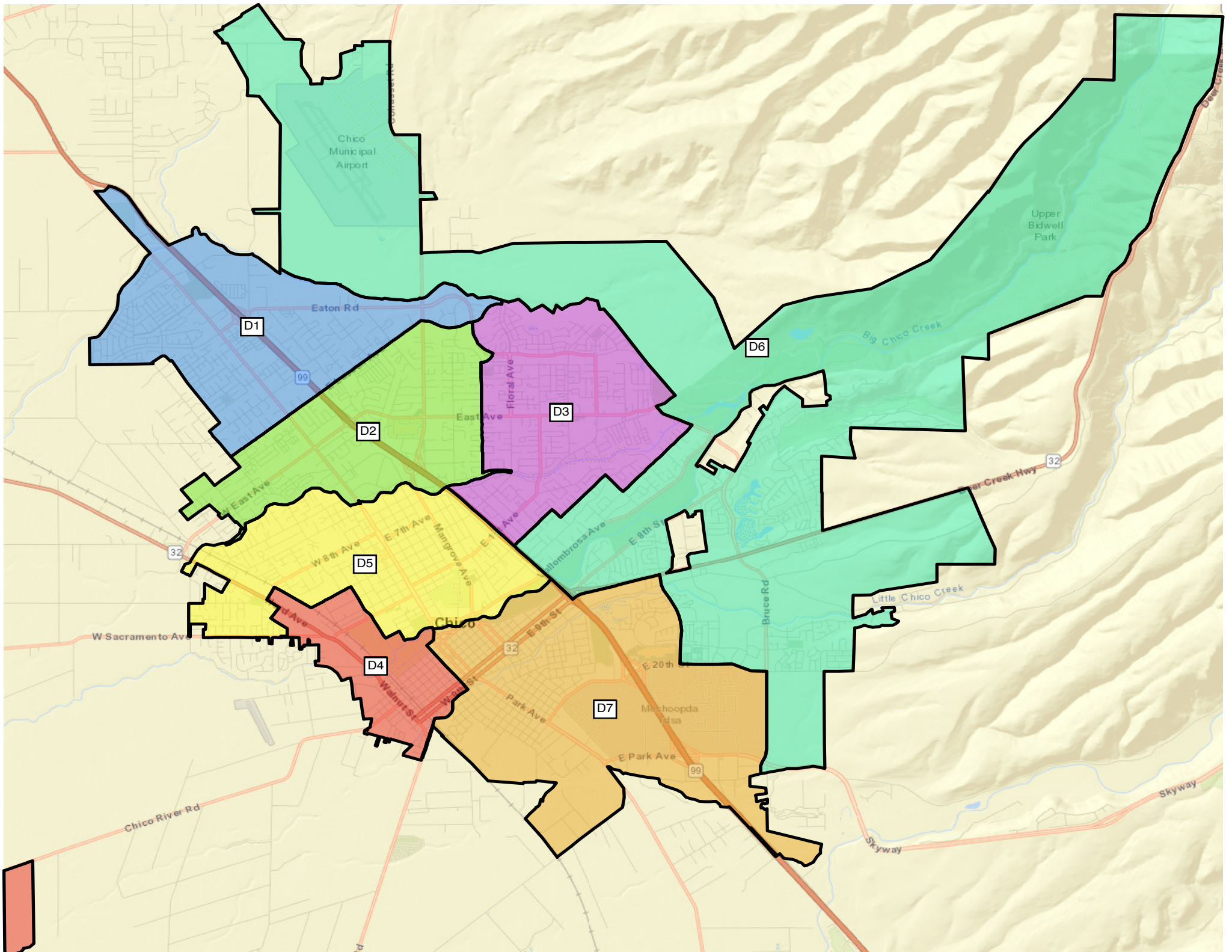




PUBLIC SUBMISSION MAP 2C:
