RECOMMENDATION

The Executive Director recommends approval of 2021-22 budget modifications and adoption of the following resolution:

RESOLUTION OF THE CHICO URBAN AREA JOINT POWERS FINANCING AUTHORITY ADOPTING THE 2021-22 FINAL BUDGET FOR THE CHICO URBAN AREA JOINT POWERS FINANCING AUTHORITY

Pursuant to Section 2.2 of the Restated Joint Exercise of Powers Agreement, this action requires the unanimous vote of all Directors.

DISCUSSION

The Chico Urban Area Joint Powers Financing Authority (JPFA) was formed for the purpose of securing financing for the construction and installation of sewer facilities and improvements to implement the Chico Urban Area Nitrate Compliance Plan through a State Revolving Fund loan. Pursuant to Section 3.1 of the Amended and Restated Joint Exercise of Powers Agreement, the JPFA is required to adopt a budget for the ensuing fiscal year.

Modifications to the current Fiscal Year 2020-21 budget are illustrated in the Estimated Final column of the Fund Summary on page 1 of Exhibit A. Nitrate Project Reimbursements (capital project costs) have been adjusted to reflect anticipated final costs for the Nitrate Projects.

The Fiscal Year 2021-22 budget includes revenues from the City of Chico acting in its capacity as Successor Agency to the Chico Redevelopment Agency (Successor Agency) and interest on investments. Operating Expenditures include \$5,900 for audit fees and \$30,928 for Indirect Cost Allocation expenses. The anticipated first year debt service on the loan with the State Water Resources Control Board is reflected in the JPFA Debt Service Fund (Fund 699).

With annual \$1,900,000 payments from the Successor Agency to the JPFA to date and the timing of construction costs, it has been determined to be more cost effective to close the loan with the SWRCB at its current balance of \$23,059,478.00 and repay \$1,152,974.00 per year rather than draw the final disbursements. This will save local match amounts that have an effective interest rate much higher than current return on investment of cash of approximately 0.5%.

For information only, Exhibit B is attached, which includes the City of Chico's Capital Improvement Program detail pages for the City projects (Projects 50138 and 50139) that will still be completed. This provides detailed expenditure information for each project that is combined in JPFA Project 50142.

24	WHEREAS, the successor agency is a separate legal entity from the City of Chico or any
25	other public agency, and its actions are governed by the members of the Chico City Council
26	acting as the governing board of the successor agency, or by the oversight board created pursuant
27	to AB 26, depending on the nature of the action to be taken; and


