The following items will be considered at the Map Advisory Committee meeting on Thursday, January 13, 2022:

- 1. Extension 21-05 for Subdivision 18-04 (Magnolia Gardens Subdivision Map Extension of Time), APN 015-440-048-000 This is a request for an extension of time in which to file final maps for the Magnolia Gardens Subdivision (S 18-04). The site is designated Low Density Residential on the General Plan Land Use Diagram and located in the R1-AOC (Low Density Residential with Airport Overflight Compatibility Zone C overlay) zoning district. This project has previously been determined to be categorically exempt from environmental review pursuant to California Environmental Quality Act (CEQA) Section 15332 (Infill Development Projects). The applicant has requested to extend the life of the tentative subdivision map six (6) years. Planning staff is recommending an extension of three (3) years, resulting in a new expiration date of 11/15/2024. - 2. Extension of Time Request for Subdivision 17-09 (West 11th Avenue) 443, 521, 525 West the Avenue; APN 043-800-013, -015, and -017: A request for an extension of time in which to file final maps for the West 11th Avenue Subdivision Map (S 17-09). The site is located on the south side of West 11th Avenue, between Holly Avenue and Sun Circle Court, designated Low Density Residential on the general Plan Land Use Diagram and is zoned R1 (Low Density Residential). The subdivision map was approved by Planning Commission on September 6, 2018 resulting in an initial expiration date of September 6, 2021. The applicant has requested a six-year extension of time for S 17-09, resulting in a new expiration of September 6, 2027. No further environmental review is required pursuant to Section of 15162 of California Environmental Quality Act. In accordance with Government Code Section 65009, if any person(s) challenges the action of the Map Advisory Committee in court, said person(s) may be limited to raising only those issues that were raised at the public hearing described in this notice, or in written correspondence delivered to the Map Advisory Committee at, or prior to, the public hearing.
