  - 2.1 <u>Use Permit 18-05 (Orwitz Walnut Street Apartments, 808, 820, 842 Walnut Street, APNs 004-265-003, -004, -005, -006-</u> This is a request to authorize ground-level residential occupancy for a multi-family residential development on a 1.25-acre site zoned CC (Community Commercial). The site is designated Commercial Mixed-Use (CMU) on the City's General Plan Land Use Diagram and is zoned CC (Community Commercial). A use permit is required to establish a ground-floor residential use in the CC zoning district, pursuant to Chico Municipal Code (CMC) Section 19.44.020, Table 4-6 (Allowed Uses and Permit Requirements for Commercial Zoning Districts). The project has been determined to be exempt from further environmental review pursuant to California Environmental Quality Act Guidelines Section 15332 (In-Fill Development). The site is designated Commercial Mixed Use (CMU) on the City's General Plan Land Use Diagram and is zoned CC-AOD (Community Commercial with Aircraft Operations Zone D overlay). A use permit is required to authorize a new drive-through sales use in the CC zoning district, pursuant to Chico Municipal Code (CMC) Section 19.44.020, Table 4-6. Furthermore, a use permit is also required to allow fencing to exceed the allowable six-feet in height, pursuant to CMC 19.60.060 (Fencing and screening). The project has been determined to be exempt from further environmental review pursuant to California Environmental Quality Act Guidelines Section 15332 (In-Fill Development). The site is currently developed with a commercial restaurant building (Country Waffles) that would be demolished. The site is designated Commercial Mixed Use on the City's General Plan Land Use Diagram and is zoned CC (Community Commercial). A use permit is required to authorize a new drive-through sales use in the CC zoning district pursuant to Chico Municipal Code (CMC) Section 19.44.020, Table 4-6.
