**4.1 AR 15-26 (LaSalles/Griffith) 229 & 233 Broadway; APN 004-081-018 & 019**

A proposed front facade renovation and downtown outdoor dining patio. The site is located on land designated Commercial Mixed Use on the General Plan diagram and in the DN-L-COS (Downtown North-Landmark-Corridor Opportunity Site) overlay zoning district. This project was previously reviewed by the Board at its October 7, 2015 meeting and continued for further review. This project has been determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301 (Existing Facilities). **4.2 COD 15-01 (Grigg) 618 W. 5th Street; APN 004-126-008-000** – A proposal to demolish a 19th-century home that is listed on the City of Chico Historic Resources Inventory. Due to the structure's extreme stage of disrepair, it no longer holds adequate historic integrity to be eligible for the City of Chico Historic Resources Inventory. The City's historic preservation ordinance (CMC Chapter 19.37) requires a certificate of demolition to be approved by the Board prior to the issuance of a demolition permit. This project has been determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 1530(L).
