Amended Services in bold:

Scope of Professional Services - Basic

The Consultant shall provide professional services as follows:

The Consultant shall provide technical review services upon request by the City and provision of two copies of the Final Map or Parcel Map, plus one copy of supporting closure calculations, deeds, title reports, or other supporting documentation.

For the first review, the Consultant shall complete the review within three weeks of receipt of all necessary documents for all maps, irrespective of the number of lots on the map.

The Consultant shall complete the second and subsequent reviews within two weeks of receipt of all necessary documentation.

For each review, the Consultant shall use a checklist to perform the reviews. Each review shall be submitted to the City with a Comment Resolution Table for use in tracing the required revisions for each map.

The Consultant's review will be limited to technical correctness and compliance with the Subdivision Map Act of the State of California and local ordinances. The City will be responsible for review of the Planning/Engineering Conditions of Approval.

Completion Schedule

The Consultant shall complete all map services outlined herein by ~~December 31, 2021~~ **December 31, 2022.**
