

## Request for Residential Exemption from the Mandatory No Wood Burn Curtailment Requirement

This form is for requesting an exemption from the mandatory no-wood burning curtailment requirement in Chico Municipal Code (CMC) Chapter 8.32 entitled "Wood Burning Regulations". CMC 8.32 prohibits the use of wood burning devices (fireplaces, woodstoves, etc.) on poor air quality days when a mandatory curtailment is in effect unless exempt based on the following criteria:
